1 PURPOSE

The purpose of this document is to provide guidance to applicants who intend to place genetically modified food and feed products on the Namibian market. These guidelines must be read together with the Biosafety Regulations (Government Notice No. 210) and Biosafety Act, 2006 (Act no 7 of 2006). The information presented in these guidelines do not preclude the applicant from any other requirements within the legislative frameworks of Namibia.

2 SCOPE

These guidelines shall apply to all genetically modified food and feed products that have been announced as such through gazetting by the Minister to be a GMO product under section (1) subsection (2) of the Biosafety Act, 2006 (Act no 7 of 2006).

4 GENERAL RULES

4.1 RISK ASSESMENT

Unless exempted, food and feed to be placed on the market must undergo by a risk assessment

that that complies with Annexure 3 of the Biosafety Regulations: Biosafety Act, 2016. Risk UG 100: Placing on the market guideline Version 01: 03/12/2016 Page 5 of 11

assessments for food must be conducted in line with Principles and Guidelines of Codex Alimentarius Commission.

4.2 LABELLING REQUIREMENTS

As per the Biosafety Regulations (*Government Notice No 210*), all GMO products which exceed 0.9% GMO content and which the Minister has pronounced to be a GMO product, must be labelled during transportation and placing on the market.

4.2.1 During transportation, GMO products must be labelled as follows:

The transporter must ensure that the consignment as well as the outermost container in which genetically modified food or feed is being transported in is labelled with the words *"contains genetically modified organisms or genetically modified organism products"* or *"product or commodity created with a GMO"*.

4.2.2 GMO products placed on the market must be labelled as follows:

5 PROCEDURE

5.1 APPLICATION PROCESS

An application for a placing on the market permit must be submitted to the Registrar on the relevant form.

The application form must be accompanied by the following:

- a) Application fee of N\$ 1000.00;
- b) An emergency response plan as set out in regulation 50 of the Biosafety Regulations: Biosafety Act, 2016;
- c) The risk assessment report and risk management plan prepared in accordance with and containing the information set out in Annexure 3 of the Biosafety Regulations: Biosafety Act, 2016;

5.2 Submission of applications

Completed applications with all relevant technical documentation must be hand delivered in hard copies (at least 10 copies) and electronic format to the Office of the Registrar at:

5.3 Advertisement of Application

According to regulation 7 an applicant must advertise his/her intention to apply for a placing on the market permit as contemplated in section 22(4) of the Biosafety Act. A copy of the advertisement together with written confirmation that it has been advertised must be submitted to the office of the Registrar no later than 7 days after submission of the application.

5.3.1 Purpose of the Advertisement

The purpose of the advertisement is to inform the public that the applicant is applying for permission to conduct a certain activity, and to request the public to submit comments or objections to the application made.

5.3.2 Publishing of the Advertisement

- a) The advertisement must be under a clearly marked heading stating "Advertisement of Application for Permit to Place on the Market Genetically Modified Food or Feed".
- b) The application must be advertised once a week for two consecutive weeks in at least two newspapers circulated widely in Namibia.

5.3.3 Content of the Advertisement


The advertisement must contain the following particulars:


- a) Full name, identification, nationality, address and contact details of the applicant;
- b) Description of the genetically modified food or feed proposed to be placed on the market;
- c) The type of placing on the market activity or activities to which the application relates as contemplated in regulation 6, sub-regulation 1 of the Biosafety Regulations: Biosafety Act, 2016;
- d) Date on which the application was submitted, together with a list of all information submitted with the application to the Registrar and the physical address and business hours of the Registrar;
- e) An invitation for interested parties to submit comments or objections, in connection with the application, to the Registrar at the address below, within 30 days after the date of the last advertisement:

5.5 ISSUING AND DURATION OF A PLACING ON THE MARKET PERMIT

Once the application for a placing on the market permit is approved, the Council will issue the applicant with a permit.

Unless specifically granted for a shorter or longer period by the Minister and indicated as such on the placing on the market permit, a placing on the market permit is valid for a period of one year and may be renewed upon application.

An application for renewal of a permit may be made as set out in regulation 9, sub-regulation 4 of the Biosafety Regulations: Biosafety Act, 2016;

5.6 INSPECTION AND VERIFICATION

A placing on the market permit holder, or any other person importing genetically modified food or feed for purposes of placing such food or feed on the market, must report the arrival of consignments of genetically modified food or feed, destined for placing on the market in Namibia at the port of entry.

The Biosafety inspectorate, in conjunction with the Agro-Marketing and Trade Agency (AMTA) border inspectorate, or any other inspector appointed in terms of section 18 of the Biosafety Act will inspect and verify any consignment throughout the duration of the permit.
